Dear Snowmass Village resident,

Snowmass Village residents may obtain their parking permits by mail. Please provide all the information requested on the back of this page, and return it together with the required items as listed:

- Pricing is for each individual Resident permit
1st Resident Permit = \$55.00
2nd Resident Permit = \$100.00
3rd Resident Permit = \$185.00
Restricted Resident Permit = \$35.00
(See other side of form for permit details.)

These prices are for each individual permit. Each residential household is allowed a maximum of three permits, out of the four available permit types. If you choose to purchase a Resident 1 permit @ \$55 and a Resident 2 permit @ \$100, the total cost is \$155.

Please send a check for the total cost of each permit made payable to "TOSV".

DO NOT SEND CASH

- **PROOF OF RESIDENCY.** If your name is listed on the county tax rolls as a Snowmass Village property owner as of September 24, 2007, no other proof is required. If your property is not listed in your name, or varies from the parking permit information for any reason (i.e. listed under a partnership or recently acquired,) please explain and attach copies of ownership evidence, e.g. a partnership agreement.
- **COPY OF CURRENT VEHICLE REGISTRATION(S).** A copy of a current vehicle registration that is in your name **must be attached for each vehicle to be permitted.**
- **A SELF ADDRESSED STAMPED ENVELOPE.** This will be used to mail the permits back to you. Out of state property owners should allow 4 to 6 weeks for delivery. If you plan to arrive in Snowmass Village earlier, do not apply for permits by mail but come to our office. Resident Snowmass Village property owners should apply by mail no later than November 7, 2007 if you would like to receive your permits prior to November 21, 2007.

Incomplete applications cannot be processed. Please recognize that, in our dynamic resort community, proof of residence must be verified annually.

I hope that our permit mailing proves convenient for you. You are always welcome to pick up your permit(s) in person at our office. Our office is located on Elbert Ln, in the upper mall level. Please bring the items listed above. If you have any questions please call our office at (970) 923-2543. Your comments or suggestions concerning Snowmass Village's parking or bus systems are always appreciated.

The Restricted Resident permit was new for the 2004/2005 winter season. If you are considering purchasing one of these permits, be sure that you completely understand its' limited parking potential; **VALID IN LOTS 10 THRU 13 ONLY**. You are allowed a maximum of three permits per household. Of the three permits allowed, you may purchase only one of each available type. Note that prices listed are for **each individual permit**.

(Attach copies of the vehicle registration for each vehicle. If you lease the vehicle, attach a copy of the lease.)

READ AND SIGN BELOW

PLEASE READ THE FOLLOWING RESIDENT PERMIT REGULATIONS AND SIGN TO INDICATE YOU UNDERSTAND THEM

- FOR RESIDENT PERMIT 1, 2 OR 3 ONLY** PARK IN LOTS DISPLAYING THE CIRCLE PARKING SYMBOL.
- THE ADHESIVE PORTION OF THE PERMIT MUST BE SECURELY AFFIXED TO THE LOWER LEFT HAND CORNER OF THE FRONT WINDSHIELD OF THE CAR TO WHICH IT WAS ISSUED.
- THE RESIDENT 1, 2 and 3 PERMITS ALLOW PARKING IN VILLAGE LOTS **1 THROUGH LOWER 5, 8 THROUGH 13 AND BASE LOT E** AT KRABLOONIK. **THE RESIDENT "R" PERMIT IS VALID ONLY IN LOTS 10 THROUGH 13.** NO OVERNIGHT PARKING IS ALLOWED IN ANY OF THE LETTERED LOTS.
- THE RESIDENT PERMIT **IS NOT VALID** FOR PARKING IN LOTS POSTED "PRIVATE PARKING", DESIGNED FOR BUSINESS OWNER PARKING, "**BASE AREA**" PARKING LOTS, OR THE "**TWO CREEKS**" PARKING LOT.
- PREVIOUS YEARS PERMITS MUST BE COMPLETELY REMOVED FROM THE WINDSHIELD TO AVOID OBSTRUCTION OF THE DRIVER'S VIEW. FAILURE TO DO SO IS A VIOLATION OF TOWN ORDINANCES.
- ANY PERSON CONVICTED OF FALSIFYING INFORMATION ON THE PERMIT APPLICATION, OR OF IMPROPER DISTRIBUTION AND/OR TRANSFER OF A PARKING PERMIT, WILL BE FINED \$300.00.
- THIS PERMIT MUST BE AFFIXED ON A VEHICLE REGISTERED IN COMPLIANCE WITH COLORADO STATE LAW.

I ACKNOWLEDGE THAT I HAVE READ, UNDERSTAND AND WILL ABIDE BY THE ABOVE CONDITIONS RELATED TO THE CORRECT USE OF RESIDENT PARKING PERMITS.
