WHAT IS A PAVER?

A paver is basically a concrete brick, measuring approximately 10.8" x 7.25" that you walk on.

HOW MUCH DOES THIS COST?

\$135.00 per personalized paver.

IS THIS TAX DEDUCTIBLE?

Yes. Your \$ 135.00 is tax deductible, a receipt will be mailed to you once your order is processed.

WHAT CAN I PUT ON THE PAVER?

Engravings are limited to

Names, Companies, Pets, Families, and Organizations.

There are 2 lines of 20 upper/lower case characters available for engraving. Spaces, "&", "-", and "," count as the 20 characters.

WHERE WILL THE PAVERS BE LOCATED?

At the base of Fanny Hill in a snowmelted area, between the Village Express lift and the Elk Camp Gondola.

WHEN WILL THE PAVERS BE INSTALLED?

Prior to the 2010/2011 ski season. Pavers will be placed randomly, exact placement cannot be guaranteed.

WILL I OWN THE PAVER?

You are purchasing the opportunity to have a name engraved on a paver. The pavers are the property of Base Village Company Inc. and the name you request will be maintained for the life of the paver.
