**ARTICLE I**

**Model Traffic Code**

**Sec. 8-1. Adoption.**

Pursuant to parts 1 and 2 of Article 16 of Title 31 and part 4 of Article 15 of Title 30, C.R.S., there is hereby adopted by reference Articles I and II, inclusive, of the 2003 edition of the "Model Traffic Code" promulgated and published as such by the Colorado Department of Transportation, Safety and Traffic Engineering Branch, 4201 East Arkansas Avenue, EP 700, Denver, CO 80222. The subject matter of the Model Traffic Code relates primarily to comprehensive traffic control regulations for the Town. The purpose of this Article and the code adopted herein is to provide a system of traffic regulations throughout the State and the nation. Three (3) copies of the Model Traffic Code adopted herein are now filed in the office of the Town Clerk and may be inspected during regular business hours. (Prior code Ch. XV §1-1; Ord. 5-2007 §1)

**Sec. 8-2. Deletions, amendments and additions to the MTC.**

(a) The following Articles and Sections of the MTC are hereby deleted: None.

(b) Section 109 of the MTC is hereby amended by the addition of the following subsection:

"109(13) No person shall operate any type of motor or motorized vehicle, excepting snowmobiles where specifically permitted, on any sidewalk, trail, path or other pedestrian way, except town and county maintenance, police, fire, ambulance and emergency vehicles are permitted."

(c) Section 228 of the MTC is hereby amended by the addition of the following:

"(9)(a) The Chief of Police is authorized to close any portion of a public street or highway within the Town to public travel or to prohibit the use thereof unless motor vehicles using same are equipped with adequate snow tires or tire chains as defined herein during storms or at such times when other dangerous driving conditions exist and, in the discretion of the Chief of Police, such closure or prohibition is necessary for the protection and safety of the public. Such prohibition or restriction of use shall be effective when signs giving notice thereof are erected upon such portion of said public street or highway, and it shall be unlawful to proceed in violation of such notice.

"(b) The following types of tires or tire chains are considered adequate:

"1. Tires with conventional mud and snow treads (M/S designation), with or without studs and minimum tread depth of 1/8 inch.

"2. Any type of tire equipped with plastic, cable, or steel link tire chains.

"3. Four-wheel-drive vehicles (all four wheels engaged) with snow tires or conventional road tread tires with a minimum tread depth of 1/8 inch."

(d) Section 504 of the MTC is hereby amended by the addition of the following:

"(7) Length limitations on certain roadways. The length limitations set forth in this Section shall apply to the following roads:

"1. Brush Creek Road.

"2. Carriageway Road, a/k/a Snowmelt Road.

"3. Snowmass Club Circle.

"4. Daly Lane.

"5. Divide Road.

"6. Elbert Lane.

"7. Fall Lane.

"8. Faraway Road to the driveway of the Ridge Condominiums.

"9. Highline Road.

"10. Owl Creek Road.

"11. Wood Road to the driveway of the Wood Run V Condominiums.

"On all other roads in the Town, the maximum length of a vehicle or combination of vehicles shall be forty-five (45) feet. A special permit for over-length vehicles for material delivery or mobilization of equipment may be granted, but not for continuous trips by vehicles engaged in ongoing construction activities related to earthwork excavation or roadway construction."

(e) Section 508 of the MTC is hereby amended by the addition of the following:

"(d) Seasonal weight limitations. There shall be a weight limitation of forty thousand (40,000) pounds GVW on all Town roads between 12:00 a.m. on March 15 to 12:00 p.m. on June 15 of every year. The load limitation may be waived or modified at the discretion of the Public Works Director based on the structural integrity of the road system in any particular year, due to climatic conditions. A special permit may be granted to vehicles used for the mobilization of equipment only; maximum GVW allowed for

five-axle vehicles (two [2] tandem axle groups) shall be sixty thousand (60,000) pounds GVW; maximum GVW for seven-axle vehicles (two [2] tri-axle groups) shall be eighty thousand (80,000) GVW.

"(e) Exemption from seasonal weight limitations. The following roads shall be exempt from the seasonal weight limitations set forth in this Code:

"1. Brush Creek Road.

"2. Carriageway Road, a/k/a Snowmelt Road.

"3. Snowmass Club Circle.

"4. Daly Lane.

"5. Divide Road.

"6. Elbert Lane.

"7. Fall Lane.

"8. Faraway Road to the driveway of the Ridge Condominiums.

"9. Highline Road.

"10. Owl Creek Road.

"11. Wood Road to the driveway of the Wood Run V Condominiums."

(f) Section 509(1) of the MTC is hereby amended to read as follows:

"Any police officer, as defined in section 18-1-901(3)(1)(IV), C.R.S., having reason to believe that the weight of a vehicle and load is unlawful, is authorized to require the driver to stop and submit to a weighing of the same by means of either portable or stationary scales or shall require that such vehicle be driven to the nearest public scales."

(g) Section 1101 of the Model Traffic Code is hereby amended to read as follows:

"1101(2)(b) Fifteen miles per hour in any business district, as defined in section 42-1-102(11), C.R.S.;

"1101(2)(c) Twenty miles per hour in any residence district, as defined in section 42-1-102(80), C.R.S.;"

(h) Section 1202 of the MTC is amended by the addition of the following subsections:

"(1) No persons shall park a motor vehicle which exceeds 18 feet in length in any Town regulated parking lot. The Town Manager may, from time to time, designate parking lots or other areas where the parking of oversized vehicles will be allowed and may promulgate such rules and regulations governing the same as it deems appropriate.

"(2) No person shall park any vehicle upon a street, highway or public parking lot in such a manner or under such conditions as to interfere with the free movement of vehicular or pedestrian traffic or proper street, highway or public parking lot maintenance and snow removal.

"(3) No person shall store any items of personal property, including but not limited to automobiles, recreation vehicles, trailers, construction equipment or materials, or similar items, in or upon any Town-regulated parking lot without the prior approval of the Town Manager. The Town Manager may impose such reasonable terms or conditions upon his approval as deemed appropriate. For the purpose of this regulation, any such item of personal property which has remained in the same general location or upon any Town-regulated parking lot for more than 168 consecutive hours shall be deemed to be stored by the owner thereof.

"(4) Whenever any police officer finds a vehicle, attended or unattended, stopped, standing or parked upon any portion of a public road, street or parking lot normally open to and accessible by the public within this municipality in such manner as to constitute a violation of Section 1204 of this code, or left unattended for a period of twenty-four (24) or more hours and presumed to be abandoned under the conditions prescribed by Sections 42-4-1803(2) and 42-4-1804(2), C.R.S., or any of the circumstances or conditions listed below, such officer shall require such vehicle to be moved, removed or cause the same to be immobilized, moved or removed and placed in storage in the nearest garage or other place of safety designated or maintained by the municipality, and neither the officer nor anyone operating under his direction shall be liable for any damage to such vehicle occasioned by such movement, immobilization or removal.

"1. Vehicle left unattended and unlocked with engine running, or ignition unlocked or keys left in the ignition switch.

"2. Vehicle stopped, standing or parked upon any area or portion of a street or parking lot in violation of or contrary to a parking limitation or prohibition set forth in the MTC, provided that such street or parking lot has been posted with an official sign or signs giving notice of such limitation or prohibition.

"3. When any vehicle is stopped, standing or parked in violation of any traffic ordinance and is an obstruction or hazard to any lawful function or restricts normal ingress or egress to property public or private.

"4. When the operator or person exercising control over a vehicle is taken

into custody by the police department and the vehicle would thereby be left unattended upon public or private property.

"5. When any vehicle is found being operated upon any road, street or public way in violation of the provisions of Sections 202, 204—210, 223 and 224 herein.

"6. When the owner or operator of a vehicle is reasonably suspected to be using invalid license plates, license permits or inspection certificates.

"7. (i) When any vehicle is reasonably suspect of being involved in any hit-and-run accident; or (ii) when any vehicle is under the control of a driver who is reasonably suspected of having been involved in any hit-and-run accident.

"8. When any vehicle is reasonably suspected of being stolen or parts thereof to be stolen.

"9. When the owner/operator of any vehicle is turned into custody for a suspected misdemeanor or felony, or when the vehicle is suspected of containing stolen goods or other contraband.

"10. When any vehicle has had an immobilizing device unlawfully removed therefrom or any vehicle has been unlawfully removed from the police storage or impounded area without obtaining a proper release for the vehicle or without payment of the required release fees.

"11. When any vehicle is stopped, standing or parked on any public street, road or alley or any private street, road, alley or driveway in a manner that restricts the clear unobstructed width to less than twenty (20) feet, when such street, road, alley or driveway provides emergency vehicle access to any building.

It is intended that fire equipment be able to position at any point along these streets, roads, alleys or driveways for the purpose of conducting fire suppression or rescue operations.

"12. When any vehicle is stopped, standing or parked within ten (10) feet of the point on the street, road, alley or driveway closest to a fire hydrant or when any vehicle in any way obstructs a fire hydrant or fire department connection for an automatic sprinkler or standpipe system that prevents its being readily accessible to the fire department.

"13. When the owner of a vehicle has failed to respond to four (4) or more notices of parking violations within the specified ten (10) days from the first notice, or if an arrest warrant has been issued for the owner."

(i) Section 1204(1) of the MTC is hereby amended by the addition of the following paragraph:

"(l) On any roadway or within six (6) feet of the main traveled portion of such roadway unless otherwise permitted by official sign."

(j) Section 1204 of the MTC is hereby amended by the addition of Subsections (5), (6), (7) and (8), which shall read as follows:

"(5) No person shall remove or cause to be removed any immobilizing device that has been installed or affixed by any personnel of the Town of Snowmass Village or remove or cause to be removed any vehicle from any authorized police storage area or impound facility without first paying any required fee and obtaining a written release from the police department and exhibiting such written release to any police officer upon demand.

"(6) As to any vehicle impounded by or at the request of the Town of Snowmass Village, its agents or employees, a person who has a legal entitlement to possession of the vehicle has a right to a post-seizure administrative hearing to determine whether there was probable cause to impound the vehicle, if such person files a written demand, on forms to be provided by the Town, with the Town of Snowmass Village within ten (10) days after the mailing of a Notice of Stored Vehicle. The Notice of Stored Vehicle shall be mailed to the registered owner or the owner's agent, based on the address reflected on the vehicle registration, within forty-eight (48) hours, excluding weekends and holidays, after impounding and storage of such vehicle.

"(7) As to any vehicle immobilized by or at the request of the Town of Snowmass Village, its agents or employees, an Immobilization Notice will be affixed to the immobilized vehicle stating that release can be obtained only after the owner (or agent) posts a bond with the Clerk of the Municipal Court or the Police Department, after which a post-seizure administrative hearing to determine whether there was probable cause to immobilize such vehicle may be held if a written request for such a hearing is made within twenty (20) days of the payment of the bond.

"(8) The post-seizure hearing shall be conducted before a hearing officer designated by the Town Manager within forty-eight (48) hours of receipt of a written demand therefor from the person seeking the hearing unless such person waives the right to a speedy hearing. Weekends and holidays are to be excluded from the calculation of the forty-eight-hour period. The hearing officer shall be someone other than the person who directed the impounding and storage, or

immobilization, of the vehicle. The sole issue before the hearing officer shall be whether there was probable cause to impound or immobilize the vehicle in question. 'Probable cause to impound or immobilize' shall mean such a state of facts which would lead a person of ordinary care and prudence to believe that there was a sufficient breach of local, state or federal law to authorize the removal or immobilization of the vehicle."

(k) Section 1205 of the MTC is hereby amended by the addition of the following subsection:

"(4) On those streets and municipal parking lots which have been approved for angle parking, no person shall stop, stand or park a vehicle at other than the angle so approved."

(l) Section 1406 of the MTC is amended by the addition of the following subsection:

"(6) No person shall place or cause to be placed snow on or upon any area that is owned or controlled by the Town, including, without limitation, parking lots, rights-of-way, roads, sidewalks or trails, unless such person has first obtained the approval of the Public Works Director."

### **Sec. 8-3. Applicability.**

This Article shall apply to every street, alley, sidewalk area, driveway, park and every other public way, public place or public parking area, either within or outside the corporate limits of the Town, the use of which the Town has jurisdiction and authority to regulate. The provisions

of Sections 1401, 1402, 606 and 1413 of the adopted Model Traffic Code, respectively concerning reckless driving, careless driving, unauthorized devices and eluding officers, shall apply not only to public places and ways but also throughout the Town. (Prior code Ch. XV §1-4; Ord. 5-2007 §1)

#### **Sec. 8-4. Penalties.**

It is unlawful for any person to violate any of the provisions stated or adopted in this Chapter. The arresting officer may offer to give a notice to the person in charge of or operating the motor vehicle involved, which notice shall be in the form of a penalty assessment notice. Should the person to whom the penalty assessment notice is tendered accept said notice, such acceptance shall constitute an acknowledgement of guilt by such person of his or her violation of the offense stated in such notice and a promise on such person's part to pay the fine specified in the official penalty assessment schedule of the Town, either in person or by mail within twenty (20) days of the date of arrest. Refusal or inability to remit the specified fine by mail when required shall constitute a refusal to accept a penalty assessment notice. The officer shall advise the person arrested of the points to be assessed in accordance with state law. Acceptance and payment of the prescribed fine shall be deemed a complete satisfaction for the violation, and the violator shall be given a receipt which so states when such fine is paid in currency or other form of legal tender. Checks tendered by the violator and accepted by the Town and on which payment is received by the Town shall be deemed sufficient receipt. Should the violator refuse to accept the notice prescribed above when tendered, the officer shall proceed to issue a summons and complaint requiring appearance of the violator in Municipal Court. Should the violator accept the notice but fail to pay the prescribed penalty within twenty (20) days thereafter, the notice shall be construed to be a summons for the particular charge indicated, and the prosecution for said violation shall thereafter be heard in

the Municipal Court, and the violator shall be privileged to answer the charge made against him or her in the same manner as if he or she had not been served with a penalty assessment summons. (Prior code Ch. XV §1-3; Ord. 4-1994 §1; Ord. 5-2007 §1)

#### **Sec. 8-5. Validity.**

If any part or parts of this Article are for any reason held to be invalid, such decision shall not affect the validity of the remaining portions of this Article. The Town Council hereby declares that it would have passed the ordinance codified herein and each part or parts thereof, irrespective of the fact that any one (1) part or parts be declared invalid. (Ord. 5-2007 §1)

## **ARTICLE II**

### **Parking Regulations**

#### **Sec. 8-21. General.**

It is unlawful for any person to operate or park a motor vehicle in violation of the provisions of this Article. (Ord. 17-1991 §1; Ord. 5-2007 §1)

#### **Sec. 8-22. Definitions.**

As used in this Article, the following words shall be construed to have the meanings defined below:

*Designated parking areas* means those areas of real property within the Town which are intended to be used for the parking of motor vehicles and which have been identified and designated by the Transportation Director.

*Merchant reserved parking* means merchant reserved parking spaces located in

Lot 7, with no more than five (5) merchant reserved parking permits issued per parking space.

*Oversized vehicle parking areas* means areas for parking motor vehicles eighteen (18) feet or greater in length as may be designated for this purpose by the Transportation Director.

*Parking permit* means a decal, hang tag, sticker or other device issued by the Town that identifies a category of parking area user.

*Parking symbol* means a symbol used to identify which parking permits are allowed in which designated parking areas which have been designated by the Transportation Director for each category of permit parking.

*Permit parking season* means a portion of each year, identified and announced by the Transportation Director, during which time it is necessary to regulate parking by permits. (Ord. 17-1991 §1; Ord. 11-1993 §1; Ord. 19-1994 §1; Ord. 10-1997 §6; Ord. 2-2003 §3; Ord. 5-2007 §1)

**Sec. 8-23. Permit required.**

No vehicle shall be parked in a designated parking area during the permit parking season unless a valid parking permit has been displayed in a manner clearly visible from outside the vehicle which authorizes parking the vehicle in the specific lot. (Ord. 11-1993 §1; Ord. 10-1997 §6; Ord. 5-2007 §1)

**Sec. 8-24. Reserved.**

**Sec. 8-25. Distribution of permits.**

No person shall falsify information on a permit application, affix a permit to a vehicle other than the vehicle appearing on the permit application, copy, alter or forge any permit or improperly distribute guest permits. Conditions relating to specific parking permits shall be as follows:

(1) Resident permits. Resident permits shall be available to those individuals who present to the Town proof of land ownership or residential leasehold interest within the Town and current vehicle registration in the name of the landowner or lease holder, for each vehicle to be permitted. No more than three (3) resident permits shall be issued per property.

(2) Guest permits shall be available for issuance by the management of any Town short-term rental unit solely for further distribution to their tenants in such units, and by the Town directly. Guest permits shall not be valid unless all information has been provided on the face of the permit, including the expiration date. The term of the permit shall be determined annually by the Transportation Director.

(3) Employee permits shall be available to eligible employees as follows:

a. Provided that the physical location of the place of business of an employer possessing a valid business license, contractor license or a franchise issued by the Town necessitates that an employee utilize Town-regulated parking lots during working hours, one (1) employee permit or one (1) transferable employee permit may be available to a qualified employee of such licensee or franchisee, as determined by the Transportation Director.

b. An employer shall be responsible to promptly notify the Town when any employee permit holder leaves his or her employ, at which time the employee permit shall become invalid and must be surrendered to the Transportation Director.

c. An employee permit may only be displayed on a motor vehicle designated on the approved employee permit application.

(4) Day skier permits. The day skier permit shall be sold at locations designated by the Transportation Director.

(5) Gold pass. Gold passes will be available to any motorist. Gold passes will be limited to an issue of one hundred (100).

(6) Senior pass. Senior passes shall be available to those individuals who present to the Town proof that they are sixty-five (65) years of age or older. A properly issued Senior pass may be utilized only by the individual to which it is issued for any vehicle that such individual is utilizing. Senior passes shall be valid only if the vehicle parked is operated or occupied by an individual age sixty-five (65) or older at the time it is parked. Senior passes will be limited to an issue of one hundred (100). (Ord. 17-1991 §1; Ord. 11-1993 §1; Ord. 4-1994 §1; Ord. 19-1994 §1; Ord. 5-1995 §1; Ord. 10-1997 §6; Ord. 2-2003 §3; Ord. 5-2007 §1)

#### **Sec. 8-26. Display of permits.**

Resident, employee, gold pass, guest or merchant parking permits shall be permanently affixed in the lower left-hand corner of the front windshield of the vehicle permitted. Day skier and transferable employee permits shall be hung from the interior rearview mirror only while the vehicle is parked. Only currently valid permits shall be displayed. Permits shall not be displayed in a manner which obstructs the driver's vision. (Ord. 17-1991 §1; Ord. 19-1994 §1; Ord. 5-2007 §1)

#### **Sec. 8-27. Fee schedule.**

(a) The charge for permits shall be determined annually by the Transportation Director.

(b) The charge for permits, per vehicle permitted per day, shall be determined annually by the Transportation Director.

(c) The charge for a parking space lease, per space, per car, shall be determined annually by the Transportation Director. (Ord. 17-1991 §1; Ord. 11-1993 §1; Ord. 19-1994 §1; Ord. 5-1995 §1; Ord. 14-1999 §1; Ord. 2-2003 §3; Ord. 5-2007 §1)

#### **Sec. 8-28. Prohibited areas.**

It is a violation of this Article for any person to park a motor vehicle in any location within the corporate limits of the Town where parking is specifically prohibited by an official sign or signs, or where parking is not specifically authorized by an official sign or signs. (Ord. 17-1991 §1; Ord. 11-1993 §1; Ord. 5-2007 §1)

#### **Sec. 8-29. Camping prohibited.**

No person shall camp in or upon any Town-regulated parking lot or upon any Town-owned property. The Town Council may, from time to time, designate an area or areas where camping may be allowed and may promulgate such reasonable rules and regulations governing camping as it deems appropriate. For the purpose of this regulation, a person shall be deemed to be camping if such person occupies any Town-regulated parking lot, or other Town-owned property, in a motor vehicle, tent or other shelter with the intent of utilizing such shelter as an abode or as a place to sleep. Camping on private property within the Town limits is regulated by Chapter 16A of this Code. (Ord. 17-1991 §1; Ord. 4-1998 §1; Ord. 5-2007 §1)

#### **Sec. 8-30. Exemption.**

The provisions of this Article shall not apply to parking in timed parking spaces which complies with the time limit for the specific parking space, or handicap parking spaces utilized by vehicles displaying valid handicap license plates or permits. (Ord. 17-1991 §1; Ord. 11-1993 §1; Ord. 5-2007 §1)

**Sec. 8-31. Penalty.**

(a) Any person convicted of falsifying information on permit applications, of transferring a permit to a vehicle other than the vehicle appearing on the permit application, of copying, altering or forging a permit or of improperly distributing guest permits shall be fined not less than three hundred dollars (\$300.00) nor greater than one thousand dollars (\$1,000.00) per violation, which shall be a strict liability offense, for which the fine shall not be suspended.

(b) Any person convicted of violating any provision of this Article, other than those listed in Subsection (a) above, shall be fined an amount not less than fifty dollars (\$50.00), nor greater than one thousand dollars (\$1,000.00) per violation, which fine shall be a strict liability offense, for which the fine shall not be suspended; provided, however, that the original penalty assessment may be paid within twenty (20) days from the date of the violation. **ARTICLE III**

**Penalty Fines and Points**

**Sec. 8-51. Penalty assessment fine and point schedule.**

The Schedule of Penalty Assessment Fines contained in Section 8-53 below shall be applicable to all violations of this Code which are specifically defined in the Schedule. If a fine is identified with a violation of a specific section of the Code, payment of the fine within twenty (20) days of the date of the citation shall avoid the necessity of appearing in Municipal Court.

For all other specifically defined violations, in which no fine or a summons is stated, appearance in Municipal Court shall be mandatory. (Prior code Ch. XV §3-1; Ord. 5-2007 §1)

**Sec. 8-52. Point assessment for scheduled violations.**

The Schedule of Point Assessments shall be maintained and assessed by the State. (Prior code Ch. XV §3-2; Ord. 5-2007 §1)

**Sec. 8-53. Schedule.**

The following is a Schedule of Penalty Assessments and Fines applicable to violations of the Model Traffic Code.
